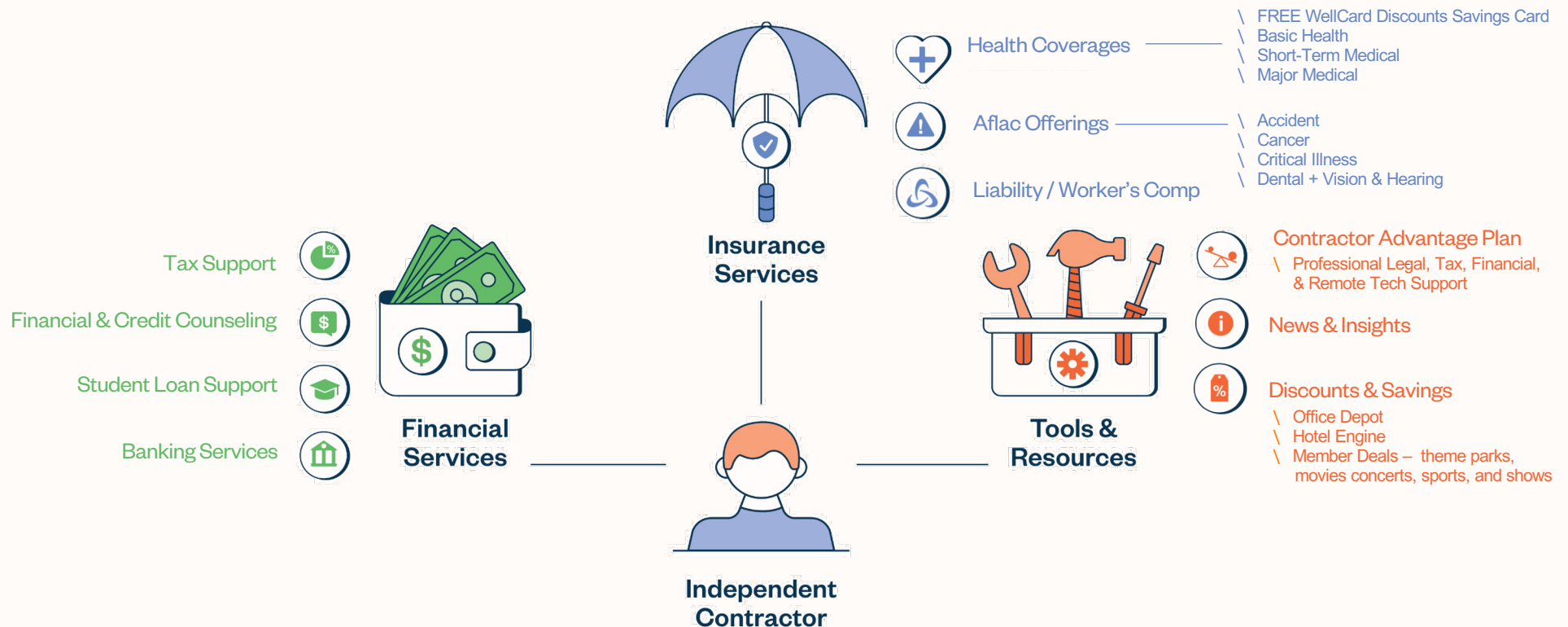
ICBA Contractor Benefits & Resources Overview
